# **Students**



NHS Staff Council has issued advice on the job descriptions and bandings for the potential paid placements that students could be deployed into during the pandemic period. Emergency legislation has been passed to enable second and third year undergraduate students, and postgraduate students, to undertake extended paid placements to support the NHS' response to COVID-19. You can download and read a copy of this letter, which confirmed that these placements can be counted towards the clinical hours required for students programme of education.

# **Returning nurses & midwives**

The NMC's Covid-19 temporary register is extended to nurses or midwives who have left the register up to five years ago.

Nurses not working in clinical care can return to clinical practice or to a range of indirect care roles such as working with students on placement and other relevant staff during the Covid-19 outbreak. More info on joining or staying on the register **on the NMC website**

# **Allied Health Professionals (AHPs)**

Health Education England is working with the Chief Allied Health Professions (AHP) Officer and AHP leadership team across NHS England and NHS Improvement, Public Health England and partners to provide a system-wide response to COVID-19 from the allied health professions (AHPs).

If you have received a letter from the HCPC please follow their instructions. This will allow you to be temporary registered and practice under protected status. For those who wish to return to the register later, you will need to follow the HCPC RTP guidance.

It is still possible to return, support and provide your skills even though not registered with the HCPC by visiting the **NHS website**.

NHS staff with visas due to expire before 1 October 2020 will be automatically extended for one year. The extension will also apply to their family members. International student nurses and doctors will also be allowed to work more hours per week in the NHS.
